*NEW license*: 0-9.99 quarter mile or 6.49 eighth mile who have not previously held a Competition License will be required to make a minimum of five (5) runs under the observation of a WDRA official, a WDRA Certified Track Safety Inspector or WDRA Sanctioned Track Operator. The required solo passes include one moderate pass, two half passes, and two full passes. Parachute must be deployed on the full passes.

*UPGRADE license*: Required to make three runs; one moderate run and two at a speed representative of the class applied for.

*INACTIVE license*: Required to make 2 complete single passes to reactivate the license and be permitted to compete in eliminations. An inactive license is defined as any racing member that has not utilized their competition license in 3 calendar years.
